Show Guidelines

- 1. Limited spaces are available and will be filled on a first-come-first-serve basis.
- 2. Artists must be 18 years of age or older or working with an adult/parent.
- 3. **Entry fee is \$35.00 per artist**. **Additional tables/spaces are \$20 each.** Each artist must have their own space. A consortium of artists (two or more artists) pay \$50/table with additional tables at \$25 each.
- 4. Artists will receive an area of 8'x 30" to display their work with one 8' table available. Electricity is limited and is available on a first come, first serve basis. (Please note this requirement on registration form).
- 5. Regardless of prior show participation, artists should submit a small biography, 3-5 photos, and a short description of your work. Artists can send via email to <u>VisualArts@dlccc.org</u>.
- 6. **Set-Up** will take place 10:00 am-3:00 pm Thursday, Nov. 9. If these hours will not work for you, please contact Carmen to work out alternate arrangements.
- 7. **Show Hours** are Thurs. 4:00pm-7:30pm / Fri. 10:00am 7:30pm / Sat. 10:00am 7:30pm
- 8. **Tear-Down** All items must be removed on Saturday, November 11 by 9:00 pm.
- 9. The Holmes will collect a consignment fee of 20% of each sale.
- 10. All sales money will be collected by The Holmes. **You must include taxes in your labeled prices** as The Holmes will not calculate/collect taxes separately. Please price your items accordingly. If your items are not correctly priced, the consignment fee increases to 30%.
- 11. **Artists are NOT required to be present during the show.** However, buyers are more likely to purchase your work when someone familiar with your items is available to engage and answer questions.
- 12. Artists must submit a **State of Minnesota Operator Certificate of Compliance/ST19** with their registration.
- 13. Each piece of art must be **clearly labeled with your ARTIST CODE** (given to you after registration) **and item's price.** Note, if not clearly priced/labeled, the consignment fee increases to 30%.
- 14. Exhibitors must display artwork on appropriate easels or display racks.
- 15. The ballroom is secured in the evening. However, The Art Show committee and/or the Holmes Theatre are not responsible for loss or damage to participant's items.
- 16. **This is a juried show and community event.** Artwork needs to remain PG13 or under as we have shoppers and viewers of all ages. Artwork/items should be handmade originals or a print/replica of the Artist's original design. The Holmes Art Show committee reserves the right to reject any artwork.
