**Show Guidelines**

1. This show is focused on arts and handmade crafts. Please ensure your wares sold are works you have a hand in making. AI art will not be accepted.
2. Limited spaces are available and will be filled on a first-come-first-serve basis.
3. Artists must be 18 years of age or older or working with an adult/parent.
4. **Entry fee is \$50.00 per artist until October 19th. Additional tables/spaces are \$35 each.** Each artist must have their own space. Starting October 20<sup>th</sup>, the price will increase to \$100 per artist.
5. **Holmes Artist Collective entry fee is \$35 per artist. Additional tables/spaces are \$35 each**
6. **Artists will receive an area of 8'x 30" to display their work with one 8' table available.**
7. **Electricity will be an additional \$10.** It is limited and is available on a first come, first serve basis. (Please note this requirement on the registration form).
8. Regardless of prior show participation, artists should submit a small biography, 3-5 photos, and a short description of their work. Artists can send via email to [VisualArts@dlccc.org](mailto:VisualArts@dlccc.org).
9. **Set-Up** will take place 10:00 am-3:00 pm Thursday, Nov. 13. If these hours will not work for you, please contact Emma to work out alternate arrangements.
10. **Show Hours** are Thurs. 4:00pm-7:30pm / Fri. 10:00am – 7:30pm / Sat. 10:00am – 7:30pm
11. **Tear-Down** - All items must be removed on Saturday, November 14 by 9:00 pm.
12. The Holmes will collect a **consignment fee of 20% of each sale**. If your items are not correctly priced, the consignment fee increases to 30%.
13. All sales money will be collected by The Holmes. **You must include taxes in your labeled prices** as The Holmes will not calculate/collect taxes separately. Please price your items accordingly.
14. **All prices must be in whole dollar amounts. We will no longer be using coins in our register.**
15. **Artists are NOT required to be present during the show.** However, buyers are more likely to purchase your work when someone familiar with your items is available to engage and answer questions. If you are interested in doing a scheduled demo, please indicate this on your form.
16. Artists must submit a **State of Minnesota - Operator Certificate of Compliance/ST19** with their registration. This is required by law for us to collect at this event.
17. Each piece of art must be **clearly labeled with your ARTIST CODE** (given to you after registration) **and the item's price**. Note, if not clearly priced/labeled, the consignment fee increases to 30%.
18. Exhibitors must display artwork on appropriate easels or display racks that you provide for your space.
19. The ballroom is secured in the evening. However, The Art Show committee and/or the Holmes Theatre are not responsible for loss or damage to participants' items.
20. **This is a juried show and community event.** Artwork needs to remain PG13 or under as we have shoppers and viewers of all ages. Artwork/items should be handmade originals or a print/replica of the Artist's original design. The Holmes Art Show committee reserves the right to reject any artwork.
